

CHAPTER I INTRODUCTION

A. Research Background

Nowadays there are many types of methods that are used in schools to make learning English easier. To make it easier for students to master English skills, proper methods are needed as well as good delivery from a teacher. A method suitable for students was adjusted to the goal of the capitation of the English lesson itself, for example in speaking material it required a continuous method of practice to enhance her ability. Vocabulary requires a method that makes students easier to remember the vocabulary so that students have a broad vocabulary to apply in the other English skills of listening, reading, listening, also writing.

Human research based on 2022 edition of the EF English Proficiency Indeks (EF EFI) released by EF Education Firs said that human resources in Indonesia tend to have low English skills. Indonesia's position is ranked 81 out of 111 countries. This position can be said to be far behind that of neighboring countries in the Southeast Asian Region, such as Singapore which is ranked 2nd, the Philippines is ranked 22nd and also Malaysia is ranked 24nd. According to the EF EPI analysis for 2022, it is also stated that Netherlands still occupies the first position.¹

Based on these data, the Indonesian state still needs to improve overall English language skills in various regions. One way that can be done is to increase new vocabulary for students. Besides that, it is necessary to have a suitable method to facilitate students in the process of memorizing new vocabulary.

The Audio Lingual Method is a method of foreign language teaching which emphasizes the teaching of listening and speaking before reading and writing. It uses dialogues as the main form of language presentation and drills as the main training techniques.

Learning Audio Lingual Method is basically about drills and conversation. The characteristics of Audio Lingual Method is about conversation and memorize. The teacher give new material to student, also the students should repeat the conversation at a time.²
