# CHAPTER I INTRODUCTION

#### A. Research Background

In the perspective of the Quran, language acquisition has many theories, one of which is contained in the Quran verses 4-5 letter al-Alaq, that:

ٱلَّذِى عَلَّمَ بِٱلْقَلَمِ Who taught by the pen (4) عَلَّمَ ٱلْإِنسَانَ مَا لَمْ يَعْلَمْ

(5) Taught a man that he knew not.<sup>1</sup>

This verse of the Qur'an shows that language is obtained from human knowledge and abilities given by Allah either through mother tongue, through teaching institutions, or through other means.<sup>2</sup>

From this explanation, we can see that language developed and obtained with the role of society. In linguistics there exists a science that is sociolinguistics. According to Trudgill, sociolinguistics is a science that studies the relationship between society and language related to phenomena and culture.<sup>3</sup> A subfield of linguistics called sociolinguistics focuses on how language is used in society<sup>4</sup>. Language in society is inseparable from culture, the language culture of each community group certainly has different norms. Wardaugh said that sociolinguistics is not a study of facts, but sociolinguistics is a study of the relationship between norms in society and the language use.<sup>5</sup> We never know what words should not be said when we are in another place or abroad, therefore politeness in speaking must always be applied properly, one of which is by avoiding uttering taboo words.

Taboo words are words with supernatural prohibited characters, or indecent ones that are considered to have no morals and are not

worth saying.<sup>6</sup> It is generally used by people to express annoyance, an attitude of being punished, embarrassed, feeling in danger, seeing something immoral, or when joking.

In the situation and condition of this rapidly developing era, taboo words seem to have coexisted with society. Words that used to be considered taboo to say and uncomfortable to hear, but now it seems as if these taboo words have become part of the language that is considered normal. For example, many young people using social media, such as Twitter, Tiktok or other social media, express what they feel through taboo words, whether it is feelings of pleasure or anger. Social media has a big impact on the use of language where in general, taboo language or taboo expressions that were previously only used by men, have now begun to be used by women, on social media. In the analysis conducted by Wika Wahyuni, comments were found on taboo words relating to things that are considered impolite and inappropriate on Instagram by women.

Not only from social media, we often encounter the taboo word through movies. We often find conversations in movies that contain it, usually found in comedy movies, they use it to get a more funny feel. Movies are one of the most popular media for people from children to adults learning languages. Movies have the attractiveness of being good for students in foreign languages, both writing skills and speaking. Through movies they imitate and practice the language, but it should be noted that not all languages in the movie can be used in the surrounding environment due to religious rules that prohibit the use of certain words and from a different cultural perspective.

There has been no study that investigates taboo words in movies that have Islamic values. Movies with Islamic values are considered a good and religious spectacle so they are safe to watch, but there are some words that must be avoided and should not be imitated because they contain taboo meanings.

Many Indonesian people use taboo words from children to adults. Children who use harsh language, of course, pass through a process that is obtained from a child's experiences in his life, starting from the

People may use these taboo words just because they just imitate the movies they watch, join the trend and think it is a cool thing without knowing the motives and meaning of the word-said the taboo. The importance of this research is to describe the meaning, types and motives of taboo words in English which are applied in the film 'Victoria and Abdul' where the movie is included with Islamic values. So that when people watch movies that have Islamic values, they do not think that all of the words in the dialogue are safe to imitate.

#### B. Research Focus and Scope

This study focuses on the types of taboo words found in the 'Victoria and Abdul' movie which is accompanied by its motives. Researcher is interested in this movie because there are values of Islamic religion where everyone who only briefly reads the synopsis of this movie will think every language is safe to use and imitate, but in fact this movie still uses taboo words in conversations that are not censored. To make it easier to find taboo words in the film, the researchers used script text. the researcher uses Wardaugh's theory to classify the types of taboo words, and uses Jay Timothy's theory to describe the motives of taboo words.

### C. Research Problems

When we want to speak, we must know the meaning of every word to avoid misunderstanding. So with taboo words, when we just say it without knowing its meaning and function, it will cause big problems. Therefore, it is necessary to explain again about language, especially related to taboo words. For these reasons, the researchers formulated several problems as follows:

- 1. What are the types of taboo words in 'Victoria and Abdul' Movie?
- 2. What are the motives of taboo words in 'Victoria and Abdul' Movie?

- 3. Victoria and Abdul is one of the most popular movies from the true story of the friendship between a British queen and a Muslim servant.
