CHAPTER I INTRODUCTION

A. Research Background

Nowadays, many languages from around the world are generally studied or just favorite, one of them is English. English is a language that we commonly find almost in everyday life. Such as the use of the word push on the ATM door. According to Juriana, the combination of the use of English and Indonesian is a sign that English has gradually started entering every aspect of human life, especially in Indonesia. English is one of the international language subjects that must be studied and included at every school level almost all around the world. Even starting from the kindergarten level, parents deliberately send their children to school with English as a second language that must be used as a communication tool at the school. However, according to Ahmad, the influence of students' attitudes and motivations will determine how well they learn in the process of foreign language learning activities.² As a result, the environment around students plays an important role in the teaching and learning process, because if the surrounding environment supports it, it will have a good impact that can determine the attitudes and motivation of students in learning.

In the era that always brings updates in science and technology along with the progress from year to year, including disease findings, education or work field. In science such as the Covid-19 pandemic era which has entered the third year so far because Covid-19 was first reported to appear in Wuhan, China in 2019. Based on *Merdeka.com*, Covid-19 began an epidemic in Indonesia on March 2, 2020. This was revealed because a Japanese citizen visited Indonesia and met two Indonesian citizens, a mother aged 64 years old and her daughter aged 31 years old who is a friend of a Japanese citizen. After coming from Indonesia, a Japanese citizen lived in Malaysia and tested positive for

the Coronavirus.³ With the publication of this news, restrictions on outdoor activities as early anticipation in handling Covid-19 to minimize its spread. This had a big impact on every field. One of them is the educational field. According to Purwanto, et al., the increasing number of Covid-19 cases in Indonesia had a significant impact on all educational institutions. The direction to conduct teaching and learning activities from home canceled face-to-face classes and replaced them with online learning.⁴ Therefore, we must follow the procedures that have been instructed by the government to reduce the number infected by this virus.

When the infected cases have begun to decrease, a new method of learning model that is suitable for the needs of teachers and students starts to apply. Based on Commission X of DPR RI with Four Ministries about Guidelines for the Implementation of Learning in the Academic Year and the New Academic Year during the Corona Virus Disease (Covid-19) Pandemic, the first instruction that allows face-to-face learning is higher education levels, the second stage is secondary education, then the third stage is elementary levels. This must be done by the predetermined time stages. However, *kemendikbud* explained that if any infected cases rise again, the education unit must be closed again.⁵ At the beginning of January 2021, *kemendikbud* issued a policy of face-to-face learning which implemented a limited basis with a shift system, strict provisions, compliance with health protocols, and parent approval.⁶ Thus, if at the beginning of the pandemic the learning model was only online learning which made the

learning process not maximal, now the blended learning model can be done in all educational institutions.

Minister Nadiem Makarim conveyed the term "Merdeka Belajar", which means teachers and students are free to innovate and be creative to learn independently. Innovative learning using blended learning model can be an alternative done by teachers by utilizing the development of Information and Communication Technology, it allows students to learn freely because of the millennial generation's tendency with gadgets as a fun learning medium. According to Huang and Qiang, the definition of blended learning model is to combine face-to-face learning environments and online learning where face-toface learning refers to traditional learning instructions in the classroom, while online learning is instructions and materials delivered online through group chats or video conferences.⁸ According to Ja'ashan, the definition of blended learning is a combination of face-to-face learning and online learning in the educational process, which is one of the important applications using information and communication technology. While definition according to Simamarta blended learning is a learning model with a combination or mixing between one learning model with other models. 10 So, it can be concluded that blended learning is the combination of face-to-face learning and online learning using internet services and technology.

During Covid-19 pandemic era, at SMP NU Putri Nawa Kartika Kudus considered implementing blended learning model with face-to-face learning and online learning. In this case, certainly still paying attention to the health protocols before entering school, such as wearing masks, checking body temperature, washing hands, and

bringing a bottle or tumbler if want to buy a drink in the canteen. 11 In learning English at SMP NU Putri Nawa Kartika Kudus, the teacher use Whatsapp application, such as in the eighth grade. 12 Whatsapp is one application widely used and has quite complete features as a supporting media in learning. According to Qamar et al, the Whatsapp application can be used in online learning as a medium for discussion to make a learning environment for students outside the classroom when blended learning is applied.¹³ However, there are obstacles to online learning. The reason is not all students use cell phones all the time because some students live in the Islamic boarding school so the teacher re-implements face-to-face learning process which is carried out in turns. Face-to-face learning is conducted in one class divided into two study groups and if any additional materials, assignments, or information, the teacher conveys them via WhatsApp group. 14 Therefore, the researcher is interested to know how the implementation of blended learning in English learning during Covid-19 pandemic era at the eighth grade of SMP NU Putri Nawa Kartika Kudus.

B. Scope of The Research

In this research, the researcher wants to know the implementation of blended learning model in English learning during Covid-19 pandemic era. This scope focuses on investigating the English learning process by applying blended learning in the eighth grade of SMP NU Putri Nawa Kartika Kudus.
