CHAPTER I INTRODUCTION

A. Background

Textbooks have a significant role in the learning process in general and in specific areas, such as language learning. Textbooks are the most common learning resource for students and teachers who want to learn English. The importance of textbooks is also emphasized by Tomlinson. Textbooks offer a learning guide for teachers and students, which helps teachers and students to be able to see what can be done in subsequent learning and what has been done in prior learning.

According to the general structures of the texts, the form of texts belonging to genre members is written language. Functions that comprise multiple forms of texts, on the other hand, can be interpreted as spoken language. Language is a means of communication between the speaker and the person with whom he or she is conversing in daily activities, and it has its own meaning and purpose.

Language is used to inform and communicate their ideas, as well as to strengthen their social relationships. Therefore it is critical for humans must connect. The speaker and the listener are inextricably linked in conversation by Wardaugh². When the use of language is appropriate for the situation and the condition of speech, it can be described as precise.

A variety of factors, known as determinants, determine the kind of language employed, such as who the speaker and interlocutor are, what the purpose is, and what the context is when the speaker is speaking. The use of language that is impacted by all of these laws is referred to as pragmatic.

Yule & Stalnaker said that pragmatism is concerned with the study of meaning as communicated by a speaker (or

Not only does understanding the meaning of words in an utterance or sentence depend on understanding what speakers intend by their utterances, but it also depends on understanding what speakers mean by their utterances. Language users can misunderstand what is being said. That comprehension was concerning the utterance or sentence's reference. Readers or listeners should be able to recognize the contexts of utterances to comprehend a reference of utterance.

Therefore, Pupier has argued that pragmatics is the study of aspects of meaning that depends on the context that is systematically abstracted away from within the construction of content or logical form⁴. Deixis, presupposition, reference, entailment, and speech acts are some of the topics covered by pragmatics⁵. The researcher used a pragmatic method in this study to examine deixis in reading text. Deixis is a word whose reference always moves or changes depending on the context to indicate person, place, time, social distinction, and role in discourse⁶.

The researcher chose "Pathway to English" for *Peminatan* Programme grade xi of senior high school textbook because, in this textbook, there are many types of deixis in this textbook that can be analyzed. When a text contains many deixes, people who read that textbook will be forced to think deeply to obtain references from the deixis.

According to Levinson there are some categories of deixis those are person deixis, place deixis, time deixis, discourse deixis, and social deixis. From those categories, the researcher employs and concentrates on three major types of
